295/16 Public Participation Period

The members of the public present had come to speak regarding the planning application at Corner Farm, ref no 15/03706/FUL. The applicant had submitted amended plans which the Parish Council had been re-consulted on. The members of the public were asking the Parish Council to re-consider its comments due to the following issues:

- Concerns re viability of the proposed development
- Flooding and risk of this increasing
- Proximity to existing houses
- More planting required to screen Greenacres
- Windows from the visitor centre overlooking neighbouring property
- Concerns re noise/nuisance
- Existing rat problem could worsen with more food in the area
- No disabled access to top floor of visitor centre
- Caravans too close to residents

Cllr. Williams advised that the planning process is about land-use, not viability. Applications must be assessed on their merits, not be negotiation. Flooding is assessed by drainage experts. Conditions can be put in a planning permission regarding landscaping.

Cllr. Williams gave his report as Shropshire Councillor. The road past Balmer that was improved needs further work as some aspects of the work were unsatisfactory – 6 inches needs to be taken off the verges, broken kerbs need repair and drainage issues need addressing. It was agreed to ask Mouchel to instruct the contractor to take care when working around the phone box.
