# Hedges next to highways

The Parish Council has been asked to remind all land owners and occupiers of their duties and responsibilities if they manage hedges next to the highway. Land owner and occupiers must ensure

- nesting birds and other wild animals are not disturbed by hedge cutting;
- hedges and trees do not cause an overhanging hazard or other obstruction to the highway;
- Growth from hedges and trees does not restrict visibility of road sings and street lights, and
- Clippings from hedge cutting activities do not cause a highway hazard.

It is the last of these points that causes most concern highway users, walkers and vehicle drivers. Landowners and occupiers should ensure that when trimming hedges the work is carried out in good visibility and to try to avoid using machinery that spits hedge debris into the highway. You should also ensure that have contractors adequate insurance as operators and/or landowner/occupiers could be held liable if an accident is caused which arises from a careless action from the operator.

### **Become a Parish Councillor!**

Do you want to help get things done in your neighbourhood? Are you already active in your community? As a councillor, you can make a difference. Welshampton and Lyneal Parish Council is looking for a person to represent Welshampton Ward on the Council.

Being a councillor is a rewarding form of public service that puts you in a unique position where you can make decisions about local issues and improve the quality of life for people within Welshampton and Lyneal Parish. It gives you the opportunity to help your local community and be part of a dedicated team influencing and providing key services for your area.

The councillor's role takes in:

- Representing the parish ward
- Decision making
- Policy and strategy review and development
- Community leadership and engagement

Being an effective councillor requires some work. The primary role of a councillor is to represent their ward and the people who live in it. Community Leadership is at the heart of modern local government and councils are taking on new responsibilities for working in partnership with other organisations, including Shropshire Council and the voluntary and community sector, to improve services and the quality of life for citizens.

Councillors are expected to take steps to keep in touch with their communities. It is hoped that they will, at least on an annual basis, attend meetings of local community groups. Councillors are also chosen to represent Welshampton and Lyneal Parish Council on outside bodies (both local and county) which include a wide range of trusts, associations and committees.

### **Police 101 Number**

Residents will be aware that properties in the Parish are connected to 2 different telephone exchanges, Welshampton and Lyneal to the Bettisfield exchange and Colemere to Cockshutt.
