44/19 Parish Action Plan 2018/19

a. AEDs

The Clerk advised she was awaiting quotes and assistance with a Lottery Grant application from the Community Heartbeat Trust

b. Heritage Projects

General discussion took place on the book to mark 'Our Gallant 35' and other projects.

c. Colemere board walk and general maintenance

The Clerk advised that as Shropshire Council had identified the cost of the repair/replacement she had not obtained quotes. Cllr Brian Williams again encouraged the Council to submit a ClL Local Fund application. The Council confirmed again it did not consider the boardwalk to be a suitable project for ClL Local Funds. The Council also had very serious concerns that should it fund/manage such a project the Parish Council would become liable for on-going maintenance, insurance etc. Areas which are

Shropshire Council's responsibility. The Council requested Cllr Williams to refer its comments back to the Cabinet member.

d. Calming measures/gates into Welshampton

The indicative quote obtained by the Clerk was discussed and it was agreed this was a feasible project to fund. The Clerk would progress the project with Shropshire Council Highways Dept and if they agreed to the installation of gates, the Clerk would obtain alternative quotes.

45/19 Councillor Reports

Cllr Wellsbury reported on progress of the Plant Fayre to be held in May.

46/19 Parish Matters

a. Emergency Planning – to identify key locations in Parish and access routes

It was agreed to carry forward this item due to the absence of Cllr Withington.

b. Litter picking

It was noted that litter picking equipment had been purchased and this would be publicised in the newsletter. It was agreed there were stretches of road too dangerous for volunteers to litter pick eg A495 between Welshampton and Newton bends. The Clerk was asked to seek advice from Shropshire Council Highways.

47/19 Highways

a. Speed restriction signage

The Clerk advised that Shropshire Council had confirmed that where there is outlying development to the main village or where approach speeds are particularly high a buffer limit 10mph above that could be introduced for the main village. Various speed limits across the County were introduced under Shropshire Council's old Village Speed Limits Policy, some of which included a 40mph buffer limit prior to the main 30mph speed limit for the village. Prior to this it was possible to put in countdown signs prior to the main village speed limit, which served the same purpose as a 40mph buffer, however, the Dept for Transport do not allow countdown signs to be used for this purpose anymore.
