Welshampton and Lyneal Parish Council

The Welshampton and Lyneal Parish Council's year 2022- 2023 was an unusually challenging one. It began with serious storms leaving damage in the parish and around reinforcing the need for our recently reviewed emergency plans.

As we continued to deal with business as usual, the year was punctuated by some significant Royal events. First, we had the late Queen Elizabeth's Platinum Jubilee Celebrations in July 2022, which was brilliantly supported by The Bonfire Committee and the Parish. Also many were delighted by the events held including the Frog Racing and the Jubilee picnic, despite being forced inside to the Parish Hall due to our British weather.

Then with great sadness the State Funeral of Her late Majesty in September 2022.

To be followed by the very recent celebrations for the Coronation of King Charles III.

On these occasions it was my honour to attend the local ceremonies and services to represent our Parish Council and residents.

Throughout the last Council year we continued to innovate and perform an extensive list of duties. All of which are duly recorded and reported on the Council's website.

For example, particularly difficult planning issues in the Parish, potholes, broadband, and Colemere access and maintenance and many other tasks. We have also developed our commitment to climate, sustainability and biodiversity thanks to our committed working group of Councillors and residents. They have held meetings which has resulted in initiatives including energy advice to help address the current cost of living issues. They are also planning events to be held this year.

Due to timing, it was my pleasure to present two Community Service Awards in the last Council year. First to Mr Frank Davis in July 22, and then to the Bonfire Committee in April 23. Both for the exemplary service they have given to the Parish and its communities.

It is also my pleasure to report that Welshampton and Lyneal Parish Council became the first Shropshire Council to successfully repeat the award of Quality Gold Status, an achievement which acknowledges the excellent work of our Clerk and Councillors and one of which we are very proud.

Finally, on a personal note, I decided not to stand

again for the post of chairperson. The council unanimously elected Councillor Karen Bland who accepted the position and I extend congratulations and offer her my full support for the
