Concerns included the flood levels of the site, the increase of population in the hamlet, the impact on the rural country lanes of the increase traffic, the impact on the local community with noise and light pollution. Members of the public advised their comments regarding a previous application on the site had been disregarded by Shropshire Council and feared the same would happen again.

Councillors agreed that the Parish Council's objections to a previous application had also been disregarded.

193/23 Development in the Parish

a. Applications Received

i. 23/04708/FUL Caravan At Heartlands Farm, Northwood, SY12 0NQ Change of use of land to a mixed use for the keeping of horses (existing) and use as a residential caravan site for an extended Gypsy family, with a total of 5 No. caravans, including the laying of hardstanding and erection of 5 No. amenity buildings.

Following discussion, the initial response to Shropshire Council was agreed:

The Parish Council has historically objected to the development of this site. It is noted the proposed development is for a change of use but the fundamental reasons for the Parish Council's objection remain:

- Development in the countryside
- Severe adverse impact on:
 - Ecology
 - Land drainage/flooding
 - Highways.

The Parish Council is also very concerned about the size of the development in comparison to the size of the hamlet which it would dominate. The level of noise and light pollution in such a rural setting should not be ignored.

The Parish Council noted that specialist reports and comments from consultees had been requested. The Parish Council would await sight of those reports and comments before submitting a comprehensive response to support this objection.
